Anti Ragging Rules 2021-22

Ragging: Prohibition, Prevention and Punishment

The University Grants Commission vide its letter no. F.1-16/2007 (CPP-II) dated June 17, 2009 has reiterated the ban on ragging of students in Institutions of Higher Learning. The students are therefore directed to strictly desist from any kind of ragging.

Forms of Ragging:

Display of noisy, disorderly conduct, teasing, excitement by rough or rude treatment or handling, including rowdy, undisciplined activities which cause or likely to cause annoyance, undue hardship, physical or psychological harm or raise apprehensive fear in a fresher, or asking the students to do any act or perform something which such a student will not do in the ordinary course and which cause him/her shame or embarrassment or danger to his/her life, etc.

Ragging Rule:

- Ragging is totally prohibited in the University campus.
- If any student is found including in ragging, severe action will be taken against the student.
- Collection of money forcefully from the fresher's will also be considered as a form of ragging.
- In case of any trace of ragging by the students, severe punishment will be imposed.
- All the senior students are instructed not to indulge in any form of ragging.

Punishment for participation in/or abetment of Ragging:

- Cancellation of admission.
- Suspensions from attending classes.
- Debarring from appearing in any test/examination or other evaluation process
- Withholding results.
- Debarring from representing the university in any regional/nation/international meet, tournament, youth festivals etc.
- Suspension/expulsion from the hostel.
- Rustication from the university for period varying from 1-4 semester or equivalent period.
- Rigorous imprisonment of 03 years and a fine of up to Rs. 25000/-
- Could be handed over to police (penalty 02 years in prison as per government rules).
- Withholding/withdrawing scholarship/fellowship and other benefits
- Expulsion from the institution and consequent debarring from admission to any other institution/university.

Note: Anti-ragging squad could visit the university campus and hostel frequently at any time.

Information for students and their parents/guardians about Ragging.

What is Ragging: (as defined by the Hon'ble Supreme Court of India)

Any disorderly conduct whether by words spoken or by an act which has effect of teasing, treating or handling with rudeness any junior student, indulging in rowdy or undisciplined activities. Which cause or is likely to causes annoyance, hardship or psychological harm to raise fear or apprehension thereof in a fresher of a junior students to ask the student (s) to do any act or perform something which the students will not do in an ordinary course and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the psyche and do a physical harm to a fresher or junior student. The cause of including in Ragging is deriving a sadistic pleasure or showing off power, authority or superiority by the senior over their junior or fresher.
