
The meeting to chalk out the action plan for effective implementation of curricular aspects was held on 29.11.2022 at 11.00AM under the chairmanship of Dean Agriculture, Kanpur. At the outset Director IQAC welcomed all the distinguished members and briefed about the necessity for the implementation of curricular aspects. After indepth discussion and deliberations action plans were formulated as given below:

1. **Curriculum design and development** -Revision of syllabus is recommended to meet out the local, regional and practical aspects. All Deans will initiate the action with the support of their HODs and course instructor. As we have just implemented the BSMA report, there is no need to further revise the syllabus of PG and Ph.D. courses during the academic year 2021-22. However, it remains applicable for all UG courses.

2. **Academic flexibility** -Choice based credit system (CBCS) which facilitates a student to have adequate freedom in selecting her/his choices across various disciplines is already in place in the university. Apart from that, we have to introduce new courses during each academic year to provide ample opportunities to the students for their knowledge gain.

3. **Curriculum enrichment** - It refers to giving greater meaning to a curriculum by adding values. Value added courses are optional, offered out of the prescribed credit load, not less than of 30 contact hours and add value to the curriculum by imparting transferable and life skills to the students. The focus is on the overall developments of students. Some of the prominent value added courses proposed for initiation are given below along with their initiator

Value added Courses on Communication skill, Emotion and stress management, Critical thinking.

Value added Courses on Professional ethics, Gender equality, Environment and Human values.
